for the Baldwin County Commission. Bids will be opened and publically read aloud in the Purchasing Conference Room located in the Annex III Building at 257 Hand Avenue, Bay Minette, Alabama. Bids received after the June 11, 2012 at the 2:00 P.M. (CDT) deadline will not be considered.

This project is funded by the American Recovery and Reinvestment Act of 2009, also known as the Federal "Stimulus" Program or the "ARRA". This contract is subject to a financial assistance contract between the Alabama Department of Transportation (ALDOT) and the Federal Transit Administration. The authorized use of real and personal property acquired with federal funds for purposes other than provision of mass transit service must have prior written approval of the Alabama Department of Transportation. Buy America provisions of the SAFETEA-LU or subsequent legislation shall apply to this Contract.


