NOTICE IS HEREBY GIVEN in accordance with Section 23-4-2 of the Code of Alabama (1975), as amended, that the Baldwin County Commission will hold a Public Hearing on Tuesday, October 18th, 2016 beginning at 9:00 a.m. at the Baldwin County Administration Building, Commission Chambers, 322 Courthouse Square in Bay Minette, Alabama to consider vacating portion of Bay View Park lying between Lots 34, 35 and Bay La Launch as set out in East Orange Beach Subdivision as recorded on Map Book 1, page 125 of the Probate Records of Baldwin County, Alabama. More particularly described as follows:

LEGAL DESCRIPTION OF PORTION OF BAY VIEW PARK PROPOSED TO BE VACATED

Commencing at the southwest corner of Lot 34 in Block 1 of the East Orange Beach Subdivision as recorded in Map Book 1 at page 125, Baldwin County, Alabama, in Fractional Section 33, Township 8 South, Range 5 East; thence run northwesterly along the west line of said lot a distance of 200 feet, more or less, to the northwest corner of said Lot and being the Point of Beginning; thence run northwesterly in a continuation of said Lot line to the bank of Bay La Launch; thence run northeasterly along the meanderings of Bay La Launch and a continuation thereof to the northeast corner of Lot 35; thence run southeasterly to the northeast corner of Lot 35; thence run

southwesterly along the north line of Lots 35 & 34 a distance of 100 feet, more or less, to the point of beginning.
