STAFF RECOMMENDATION	
Acknowledge for the record, the termination of the Agreement between the Baldwin County Commission and East Point Baptist Church, for the provision of the use of the voting place (East Pointe Baptist Church, Blakeley/North Greater Spanish Fort Area) for Baldwin County Voting Precinct 45 and for the provision of professional cleaning services in the voting place after any election. Per Section 7 of the Agreement, the Agreement became void upon the Commission accomplishing electoral changes on May 17, 2016, relocating the polling place in Voting Precinct 45 from the East Point Baptist Church to the Spanish Fort Community Center.

<p>In accordance with applicable Alabama Law, the Baldwin County Commission, during its May 17, 2016, regular meeting, adopted Resolution #2016-064 which approved a certain voting changes applicable to Baldwin County.</p> <p>Related to Voting Precinct No. 45 (Spanish Fort North), the polling place was relocated from the East Pointe Baptist Church to the Spanish Fort Community Center, as located at 7361 Spanish Fort Boulevard, Spanish Fort, Alabama.</p> <p>The Commission has had an Agreement with the East Pointe Baptist Church since February 3, 2015, for the provision of professional cleaning services provided to the church after any election. Section 7 of the Agreement states the Agreement shall immediately become void</p>	

upon the Commission accomplishing any electoral changes which negate the utilization of the East Pointe Baptist Church as a Voting (Polling) Place as determined by the Commission in its discretion.
