<p>Approve the revised Contract for Professional Emergency Medical and Ambulatory Services between the Baldwin County Commission and Lifeguard Ambulance Service, LLC d/b/a Medstar EMS. This Contract shall be effective and commence immediately upon the same date as its full execution, and the same shall terminate upon the expiration of twelve (12) months or upon a written notification thereof received by either party within the required thirty (30) day period.</p> <p>This Contract will replace, supersede and make null and void the previous Contract for Professional Emergency Medical and Ambulatory Services between Baldwin County Commission and Medstar EMS, which was approved by the Baldwin County Commission on August 30, 2008.</p>

The proprietors of Lifeguard Ambulance Services, LLC have requested that the Contract for Professional Medical and Ambulatory Services between the Commission and Medstar EMS be revised to include "Lifeguard Ambulance Services, LLC d/b/a Medstar EMS" where applicable in the document.</p> <p>In addition, the Baldwin County Shelters north of I-10 have been added to this contract for redundancy.</p> <p>This revision will make null and void and replace the previous contract with Medstar EMS.</p>
