STAFF RECOMMENDATION	
Consider the transfer of the 050 - Retail Beer (Off Premises Only) and 070 - Retail Table Wine (Off Premises Only) license applications from Bay Shore Oil, Inc. d/b/a Fish River Pride to Hari 1, LLC d/b/a Fish River Food Mart, located at 10525 Highway 98, Fairhope, Alabama 36532 and approve the issuance of said licenses by the Alabama Alcoholic Beverage Control (ABC) Board, if the public hearing does not reveal a legitimate reason to deny the applications.

Staff has verified all sales tax requirements have been satisfied, the business meets the Health Department's requirements and the Baldwin County Sheriff's Office does not oppose the issuance of the license.	
The public hearing for Hari 1, LLC d/b/a Fish River Food Mart was previously scheduled for November 1, 2015. The applicant was not able to attend the hearing or provide the proof of publication to the Commission at that time; therefore, the Commission postponed the hearing for a later date. Because the State ABC Board requires the applicant to reapply if certain timelines are not met, the applicant has now reapplied for the same license transfers as previously and a new public hearing date was set for December 6, 2016. The applicant is required to re-advertise and provide proof of publication to the Commission before the hearing takes place.
