Department of Youth Services (DYS) Part 1 and Part 2 Grant/Subsidy Agreement Fiscal Year 2016-2017

STAFF RECOMMENDATION

Take the following actions:

- 1) Execute the Alabama Department of Youth Services Part 1 Grant/Subsidy Agreement Fiscal Year 2016-2017, which awards the Baldwin County Regional Juvenile Detention Center \$14,000 per county for providing 6 counties at a minimum of one bed per day per county for a total of \$84,000 for the following counties:
Baldwin, Choctaw, Clarke, Conecuh, Escambia and Washington; and
- 2) Execute the Alabama Department of Youth Services Part 2 Grant/Subsidy Agreement Fiscal Year 2016-2017, which awards the Baldwin County Regional Juvenile Detention Center \$69,966 for the population of the regional service area. The formula provides \$0.2682012 per person based on the 2010 U.S. Census; and
- 3) Authorize the Commission Chairman to sign the agreement and any related documents.
